Its slow release polymer formula blend allows for nitrogen release over the growing season for longer potential growth. **UPGRADE** minimizes urea dissolution and volatilization. **UPGRADE** eliminates another trip over the field, saving money and time.

DIRECTIONS FOR USE

To obtain optimum coverage of **UPGRADE** on granular fertilizers, it is APTC's recommendation that high-pressure spray be utilized. If conventional low-pressure spray is used, coverage of **UPGRADE** can be compromised and some of the fertilizer may not have the optimum **UPGRADE** coating.

Typical spray application equipment, such as a gear pump and high-pressure nozzles should be used for applying **UPGRADE** onto urea for even and uniform coverage. If you need information on high-pressure spray application equipment, call a spray equipment supply company.

UpGrade is applied to Urea by the Fertilizer Dealer. UpGrade has a 'red' dye added so that you can tell if your urea has been 'UpGraded.' Application Recommendation for Granular Urea or Granular Urea Fertilizer Blend Only.
